Pacific National has not agreed to the following:

- 12% Super

- The claiming for rostered shift for Personal Leave
- Total remuneration of APM towards Personal Leave
- Extending the 3 hours notice for a Cancelled Shift
- 2<sup>nd</sup> Leg not credited if 1<sup>st</sup> leg cancels
- MRD claiming rostered Shift
- Not removing Lift up / Lay Back
- Payment of BMI testing in Cat 1 medicals

RTBU has not agreed to the following:

- 6 weeks duty cycle
- 3.75% pay increase per year
- All Overtime reduced to 1.7
- Training Bond
- LSL payout between 5 and 10 years of service
- 10klm Rule for Depot Relocation
- Locations for Cat 1 medicals unless rostered
