Prospective candidates and nominators should verify their financial status and any other qualifications required by the Organisation's rules prior to lodging nominations.

Nominations must reach the Returning Officer via the lodgement method(s) stipulated below not later than 5:00pm Australian Eastern Daylight Time (AEDT) on 17/02/2023.

2. In order to be able to be received by the AEC, emails (including attachments) should be no greater than 6 MB in size.

### **Withdrawing Nominations**

Nominations cannot be withdrawn after 5:00pm Australian Eastern Daylight Time (AEDT) on 24/02/2023.

### **Candidate Statements:**

Candidates may submit a statement, as a Microsoft word document, not exceeding 250 words. A passport style photo may also be submitted with the candidate statement for publication. Statements must not contain any derogatory or inappropriate language and must be received by the Returning Officer not later than 5:00pm Australian Eastern Daylight Time (AEDT) on 17/02/2023.

### **Voting Period**

The postal ballot, if required, will open on 17/03/2023 and close at 5:00pm Australian Eastern Standard Time (AEST) on 14/04/2023.

The **Attendance ballot**, if required, will be held on **Thursday, 23 March 2023** between 7:00am and 4:30pm (AEDT) for offices representing members within the **Tram and Bus Division** only. Details will be advertised separately at each workplace following the close of nominations.

### **Scrutineers**

A candidate in any election shall be entitled to appoint, by notice in writing to the Returning Officer, another person to act at his/her own expense as a scrutineer on his/her behalf. A form is available from the Returning Officer for the purposes of appointing Scrutineers.
